- Investigate Depot/RRU/VMU breakdowns and defects to identify root causes and put in place actions to maximise machine availability.
- Provide engineering advice and support to site operational teams in regards to site operated plant and equipment.
- Manage revenue budgets and identifying any variances.
- Investigate root causes of any external authorities issuing a non compliance notice.
- Build a relationship with contractors, third party providers and external authorities.
- Reduce damage spend YOY through identifying root causes and implementing procedures and requirements to prevent reoccurrence.
- Prepare input to both revenue and capital budgets to ensure that legal and maintenance compliance is maintained.
- Ensure that repair and maintenance costs are in line with budget expectations and that Sainsburys
 are getting the most cost effective value for money repairs by contractors and highlight any variances
 in maintenance and damage spend.
- Manage maintenance repairs ensuring they meet contractor requirements and SLA's. Address areas of contractor under performance in a timely and effective way.
